Completing the Community Dialogue

The Community Dialogue on Neighbourhood Character and Housing Working Group has guided a year-long consultation process with the residents of West Vancouver on issues related to housing choice and affordability, and neighbourhood character. This has provided a public forum for identifying and discussing fundamental issues facing our community. The Working Group completed this process in July 2008, and presented its final report to Council in September 2008. This newsletter provides a brief overview of the Working Group's recommendations and outlines opportunities for further public input.

Themes

Two major themes emerged during the Community Dialogue:

1. Residents acknowledge that the community "needs to change to effectively stay the same", and that "doing nothing" is no longer an option. Through the Dialogue, we gained the understanding that we have to make some changes to the structure of our community if we are to protect what we value, and if we hope to remain in the community as our own needs change over time.



2. A majority of West Vancouver residents would like to see thoughtful and effective actions undertaken by Council to address real community concerns over housing choice and affordability, and the changing character of West Vancouver's established neighbourhoods.

Residents also shared with us the following goals:

- To protect the distinctive characteristics that have made West Vancouver such a unique community.
- To respect nature by minimizing landform alteration, preserving natural site features, and enhancing opportunities for enjoyment of nature.
- To plan for new housing types to meet the community's changing needs, but in forms that respect the established scale and character of West Vancouver neighbourhoods.
- To create more opportunities to downsize to smaller housing units, including modest gardens and outdoor space.

The Personal Stories

Throughout the Community Dialogue, residents shared their personal stories. The Working Group heard about the desires and struggles of individual residents wanting to maintain their homes and neighbourhoods, and remain in the community as their needs change, over the long term.

While each story was unique, similar messages were heard over and over. Three of these narratives are retold in this newsletter using fictionalized characters. Taken together, these stories illustrate some of the key housing challenges in West Vancouver.

Katherine

Katherine is a recently widowed senior on a fixed income. While she has been able to find a condominium for sale close to transit and other services, she would not have any money remaining from the sale of her house to supplement her income. She will have to leave her community of 35 years to find more affordable housing.

Working Group Recommendations

The Community Dialogue on Neighbourhood Character and Housing has concluded with a plan for action. This 'plan' is outlined in a series of 20 recommendations; the key recommendations are briefly summarized below:

- Revise District policies, regulations, and processes to achieve the sustainable community that is envisioned in the OCP
- Enhance and protect neighbourhood character by:
 - Articulating the character of distinct neighbourhoods in key District policies
 - Conserving our heritage
 - Encouraging 'designing with nature'
 - Making construction more 'neighbour friendly'
- Increase housing choice and improve housing affordability by:
 - Amending key District policies to recognize alternate housing types
 - Exploring new housing types through a series of targeted 'pilot projects'
 - Developing an affordable housing strategy
 - Legitimizing secondary suites in single-family dwellings
 - Encouraging environmentally sustainable housing and landscape design
- Ensure the livability of new and established neighbourhoods through:
 - The creation of additional village service nodes
 - Opportunities for reducing reliance on the private automobile
- **Ensure that the 'Dialogue' continues** through the use of community workshops and other public engagement tools

The implementation of the Working Group's recommendations is now up to District Council and staff. We encourage you to stay engaged in the public process, and hope that you will continue to participate in future public discussions on these issues, and provide your thoughtful input on implementing solutions to housing and neighbourhood character issues.

The Personal Stories Arthur & Grace

They realize that they will need some flexibility to accommodate Arthur's mom over the short term, and possibly their adult daughter when she moves back to West Vancouver in a couple of years. While they have the financial means to afford a large new single-family house, they would prefer to live in a smaller low-maintenance house, with detached accommodation for family members and possibly a care-giver in the future. They would still like to have a garden and backyard, as do most West Van residents, but on a smaller, more manageable scale that is appropriate to their stage in life.

The Personal Stories **Sandra**

Sandra is a disabled adult whose parents have reached the age when they can no longer drive to North Vancouver to visit her in the group home in which she lives. They would like to see her established in a group home in West Vancouver where they can visit easily and know that she will be competent in this new environment for the rest of her life
